Dear Hunting Club President:

Thank you for your hunting club renewal payment. Please find enclosed for your records your copy of the fully executed license for the 2015-16 season.

Please review your license agreement and documentation with all members. Following are some highlights of what is required of our licensees to remain in good standing. To be sure you are not in violation of your license read it in its entirety; do not rely on these bullet points alone:

- Follow all the laws of the State of Louisiana.
- Comply with RMS "Good Neighbor Policy" addendum to the license
- Don't interfere with ongoing RMS operations; this is a WORKING forest
- We take a "zero tolerance" approach to problems caused by irresponsible or illegal hunting behavior, and such documented behavior is grounds for immediate termination of the hunting license agreement with cause.
- Campsites – All new ones must be pre-approved.
 - Review the total number of campsites and structures and correct if needed. Your club will be charged for each individual camp remaining on site beyond May 1.
 - Keep your camp site clean. All trash, unused hunting equipment and campers must be removed.
- Section 9 of the License – *Protection of Timber and other Property* - read and make sure your club follows – it contains among other items:
 - Don't destroy RMS managed property- roads, trees, streams, etc.
 - Contact RMS if you see any problems we need to be made aware of
- Under Section 13 *License Privileges* – Among other items - You must get approval from your Lease Manager for new food plots, shooting lanes, camp sites or any type road work. We continue to have problems with clubs that violate Louisiana Best Management Practices while conducting road work.
- Per the enclosed amendment to your lease, please make all members aware of our policy prohibiting the use of explosive targets on your lease.

The vast majorities of RMS licensed clubs are well managed and valued customers. We appreciate the respect you show to our neighbors and the local community, and adherence to our license and Good Neighbor Policy. It is our sincere hope that your club enjoys its privileges under its license. And above all, we hope your club has a safe season.

Dear Hunting Club,

Paragraph 23 of the RMS Outdoor Recreational Activity License Agreement with your hunting club allows RMS the ability to amend the License Agreement at any time upon written notice to LICENSEE.

Please be advised, as of the date of this letter, the aforementioned agreement is hereby amended by the addition of a new section (i) to Paragraph 9 as follows:

- i. LICENSEE will not use explosives or exploding targets of any kind, including but not limited to Tannerite ® or other explosive compounds or incendiary devices in exploding targets, for any use or purpose, at any time on lands licensed from LICENSOR.
